Call for participation

REGULATION

Art 1- **SOLOCOREOGRAFICO YOUTH** is an international weekend dance program based on three different european cities (Torino, Lyon, Frankfurt) designed for young dancers and dedicated to solo choreography.

for each editions, participants will have the right to:

- 5 dance workshops
- performing on stage
- participate in the selection to perform with the professionals
- 2 free tickets for every show of the festival (1 for the participant, 1 for the accompanying person)

After performing the solo on stage, a jury of professionals in the field of dance, will select three dancers, who will be called to dance in the next possible edition of the festival together with professional dancers. Depending on which city they will be participating in, they will dance in one of the following editions: Frankfurt, or Turin, or Lyon, presenting a solo of their choice.

Selected young dancers will have the right to participate in the next possible festival edition, and have the right to:

- 5 free dance workshops
- free performing on stage, with young dancers and professionals
- 2 free tickets for every show of the festival (1 for the participant, 1 for the accompanying person)
- free Hotel accommodation during the festival (double room)

The artistic director, Raffaele Irace, wishes to welcome the young dancers within an accredited international event (Solocoreografico Solo Dance Festival) by making the professionalism of his organization available. (www.solocoreografico.com).

Art 2 - Age, categories, choreography

The dancers must be between the ages of 12 and 17, or if they are already adults 18+, they must be students of a dance school or dance academy.

There is no age limit for the choreographer.

The category will be unique, as the event will select young artists based on their artistic quality as well as technique, not on their age.

More choreographies can be submitted. Starting from the second choreography - danced by the same dancer - fifty percent of the fee will apply.

The choreographer can also be the interpreter of the choreography presented.

The style and genre of dance, the choice of drama and music are at the discretion of the choreographer.

The maximum duration allowed is 4 minutes.

The candidate choreography may have already been presented at other events in the past.

Art 3 - Participation fee, deadlines

Starting this year it is possible to register for all three editions with only one application.

- Frankfurt edition 12 & 13 October 2024 (deadline 6 October)
- Torino edition 23 & 24 November 2024 (deadline 17 November)
- Lyon edition 1 & 2 February 2025 (deadline 25 January)

Registration fee for 1 edition, full program 120,- €

Registration fee for 2 edition, full program 210,- €

Registration fee for 3 edition, full program 280,- €

- Only participation in the workshops is also foreseen, with the following fees: 1 class 20,- € / 2 classes 35,- € / 3 classes 45,- € / 4 classes 55,- € / 5 classes 65,-€

Notice: the only participation to the workshops will not include performing on stage, or free tickets for the shows.

- In addition to the regulation and the signed registration form, send a valid certificate of sound and robust physical health as an attachment, and the copy of the payment for registration, to the following email address: solocoreografico@gmail.com, Object of the email should be: Registration Solocoreografico Youth - Name Surname

IMPORTANT: write the data of the person (Name, Surname, address and tax code) who made the payment via email to solocoreografico@gmail.com, to allow our administration to issue a regular invoice.

The choreographer and/or contact person is responsible for the authenticity of the documentation provided. Should the organization find the untruthfulness or incompleteness, the participants will be excluded from the youth program.

Only registrations received via the official form which can be downloaded from the website www.solocoreografico.com are valid.

Art. 4 - **Rehearsals**

There are no rehearsals of the choreography on stage, but only a brief assessment of the scenic space.

Art. 5 - **Music**

The music tracks must be exclusively in .mp3 format named as follows:

Name Surname performer - Choreography title. They must be sent by email to solocoreografico@gmail.com with the submission of the application.

Choreographers must bring a backup copy of the piece on a USB drive with them, in case of need.

Article 6 - **Lights**

A fixed light design will be available for all the choreographies.

It will be possible to choose between a warm or cold light design.

The light design will be fixed and cannot be modified.

Art. 7 – **Candidates attending the show**

During the selection phases, participants will be able to access the audience area based on the availability of seats.

Art. 8 - **Jury**

The jury is made of personalities and dance professionals, artistic directors, choreographers, dancers, programmers, agents, journalists.

The organization may at any time change the composition of the jury if it is necessary or due to force majeure.

Art. 9 – **Evaluations and selection**

The Jury will be made of international dance professionals and chaired by the artistic director Raffaele Irace.

The intelligent and creative use of space and time, the realization of an idea through a choreography for the dance of a single performer and the talent of the same, will be the cornerstones for the evaluation of the performances, regardless of the style proposed and the age of the candidates.

The results of the selection will be communicated at the end of the performances by the artistic director and the jury. The following day the names will be published on social and web channels. The Jury's decision will be final.

Art. 10 - **PRIZES**

The Jury will select a maximum of 3 choreographies that will participate in the international festival for professionals *SOLOCOREOGRAFICO Solo Dance Festival* during one of the next possible editions in Frankfurt - Germany, Torino - Italy, and Lyon - France.

The selected choreographies will be performed during the festival evening. The invited dancers and choreographers will have free access to all the workshops and shows during the festival days.

The organization will be responsible for the accommodation in a double room with breakfast, for the duration of the festival, both for the selected dancer and for an accompanying choreographer / tutor.

Participation in the festival for professionals is a great opportunity for visibility and sharing for both choreographers and young artists, to directly access a unique professional and international artistic community.

(For registered participants plus one person, entrance is free. Those attending only the dance classes will pay a reduced fee)

Art. 12 – **Video recordings and photographs**

Photographers and video operators not authorized by the theater will not be admitted during the show.

The organization will produce a film and photographs necessary for the documentation of the event. Videos and photographs will be available for purchase in the days following the event.

Art. 13 – **Cancellation**

The organization avails itself of the right to cancel the event should there be reasons of proven force majeure. In this case the registration fees will be refunded. In case of non-participation in the event for reasons not attributable to the organization, for renunciation or otherwise, you will not be entitled to any refund of the fee.

Art 14 - **Use of images**

The organization of the event reserves the right to use images and videos of the performances for possible television or internet passages. The participant and whoever takes his place assigns to the Organization all rights relating to the use of images and videos created during the competition. This means that the participants and whoever takes their place will not be able to claim any type of economic request for the possible use of the images and videos used in the aforementioned methods.

Art. 15 – **Use of personal data**

The organizer is authorized to acquire and use (unless written dissent) the personal data, released by each participant for promotional, informational and statistical purposes in accordance with the laws in force. Personal data will in no case be transferred to third parties.

Art. 16 - Physical health

The participants in the Competition, or whoever takes their place, declare that they are in good health as per the medical certificates in their possession and already delivered during the registration phase. The Organizer also declines all responsibility for damage to property or persons that may occur during the various stages of the event, whether suffered or caused by the contest participants themselves or by their companions.

Art. 17 - Acceptance of the regulation

Participation in the Competition implies the unreserved acceptance of these regulations and any additional rules that the organization reserves the right to introduce and which take on equivalent value to the regulation itself. In the event of non-compliance with the provisions of these regulations, the Organization may also adopt the measure of expulsion from the Competition. In this event, the participant is not entitled to any refund or indemnity.

Article 18 – Responsibility

Excriminating consent of the entitled person. The organization is exempt from any type of liability as any damage to persons (himself or others) or to things occurring in the practice of dance on the occasion of the competition must be considered covered by the consent of the entitled party, relieving the participant and the organization from any and all responsibility in this regard, and by signing this regulation and the registration form as a formal provision of consent in terms.

Liability waiver for things or valuables of the participants in the competition.

The organization is not liable for the loss, theft or deterioration of things or valuables and personal effects of the members brought into the competition venues.

Art. 19 – Extraordinary decisions and assessments

For anything not covered in these regulations, every decision rests with the artistic direction of the organization.
